## CorEnergy Declares Dividends & Schedules Earnings Release for Third Quarter 2016

KANSAS CITY, Mo. - October 26, 2016

### Declaration of Common & Preferred Dividends

CorEnergy Infrastructure Trust, Inc. (NYSE: CORR, CORRPRA) (“CorEnergy” or the “Company”) announced today that its Board of Directors declared a third quarter 2016 dividend of \$0.75 per share (or \$3.00 per share annualized) for its common stock. The dividend is payable on November 30, 2016, to shareholders of record on November 15, 2016.

The Board of Directors also declared a cash dividend of \$0.4609375 per depositary share for the Company’s 7.375% Series A Cumulative Redeemable Preferred Stock for the third quarter, ending September 30, 2016. The preferred stock dividend, which equates to an annual dividend payment of \$1.84375 per depositary share, is payable on November 30, 2016, to shareholders of record on November 15, 2016.
