CorEnergy Declares Common and Preferred Dividends and Schedules Earnings Release for Third Quarter 2018

KANSAS CITY, Mo.- October 24, 2018 - CorEnergy Infrastructure Trust, Inc. (NYSE: CORR, CORRPrA) ("CorEnergy" or the "Company") announced today that its Board of Directors declared a third quarter 2018 dividend of \$0.75 per share for its common stock. The dividend is payable on November 30, 2018, to shareholders of record on November 15, 2018.

The Board of Directors also declared a cash dividend of \$0.4609375 per depositary share for the Company's 7.375% Series A Cumulative Redeemable Preferred Stock. The preferred stock dividend, which equates to an annual dividend payment of \$1.84375 per depositary share, is payable on November 30, 2018, to shareholders of record on November 15, 2018.
